## **ACHC Receives Renewal of Deeming Authority from CMS for Home Health Accreditation**

**CARY, N.C.** (Feb. 21, 2025) – Accreditation Commission for Health Care (ACHC), a nonprofit accreditation organization committed to offering exceptional service and a collaborative accreditation experience, has received continued approval from the Centers for Medicare & Medicaid Services (CMS) as a national accrediting organization for home health agencies (HHAs). This renewal, effective until 2031, affirms that ACHC's accreditation program meets or exceeds Medicare Conditions of Participation (CoPs) for HHAs.

- A comparison of ACHC's accreditation process with CMS survey requirements, including monitoring noncompliance and responding to deficiencies.
